FRAME SUPPLIER SELECTIONS:

Lab Supplied

- Complete new order (frame and lenses), billed from Maui Jim to VSP.
- Account will be billed by VSP for the frame.

If the account wants to purchase the frame from Maui Jim at the time of submitting the order instead of mailing a frame, they can check the **Lab Special Instructions box and write, "Maui Jim Supply Frame." Maui Jim will then bill the account for the wholesale Rx frame price and supply the frame for the order.

Doctor Supplied

- Patient is using frame benefit.
- ECP customer is sending frame from their in-office inventory to Maui Jim, OR
- ECP customer is purchasing frame from Maui Jim at time of submitted order instead of sending frame from ECP in-office inventory.

*NOTE - The ECP customer MUST check the **Lab Special Instructions** box and write in, 'Maui Jim Supply Frame'.*

This will que Maui Jim to supply the frame and bill the ECP customer at wholesale Rx frame price for this order.

This process will not delay the processing of the patient's order.

Patient Supplied-To Come

- Patient is not using VSP frame benefit.
- Patient's own frame is being sent to Maui Jim from ECP customer, OR
- ECP customer is purchasing frame from Maui Jim at time of submitted order.

*NOTE - The ECP customer MUST check the **Lab Special Instructions** box and write in, 'Maui Jim Supply Frame'.*

This will que Maui Jim to supply the frame and bill the ECP customer at wholesale Rx frame price for this order.

This process will not delay the processing of the patient's order.

HELPFUL TIPS:

- Do not change the wholesale frame cost that populates in eClaim (or eLab). These have been provided by Maui Jim to ensure accurate billing and claim payment by VSP.
- Use the Maui Jim Rx Reference Guide to verify the frame parameters. Eyefinity will allow out-of-range orders to submit to the Maui Jim lab, but will not be processed.
- The quickest way to search for the frame is by frame name or sku number (ie: Ho'okipa or 407-02).
- The frame for Maui Jim sun prescription orders must begin with "**mjr**" in the color description.
- When ordering, there is no need to select an A/R coating separately as it is automatically included with all Maui Jim lenses.
- There is no need to enter "proprietary" into Box 19 Special Instructions, and doing so will cause your order to not process correctly.
